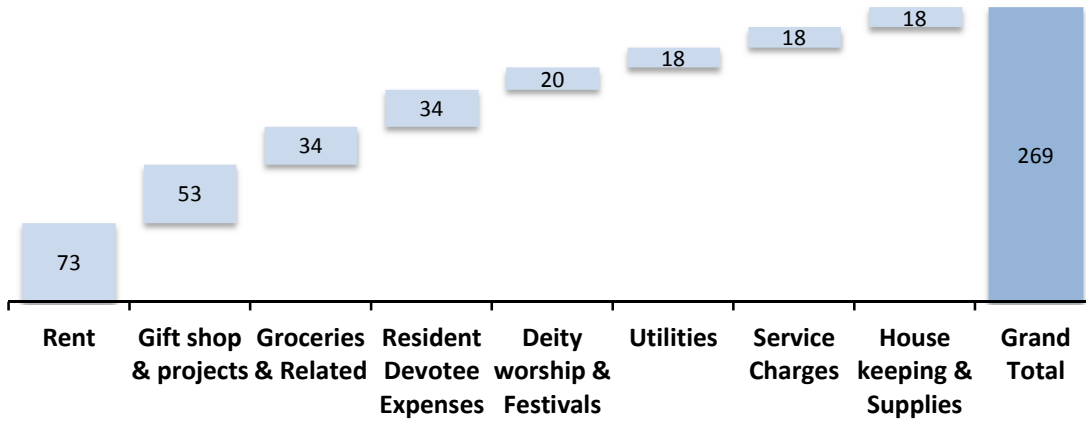

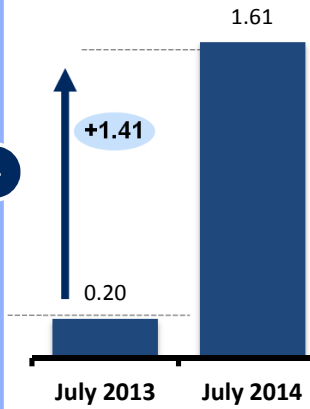
Annual Expenses (7/2013 to 7/2014)

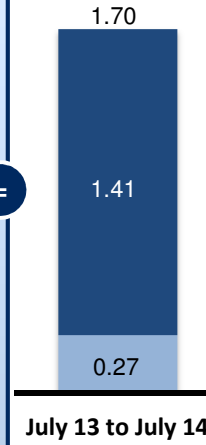
Increase in assets

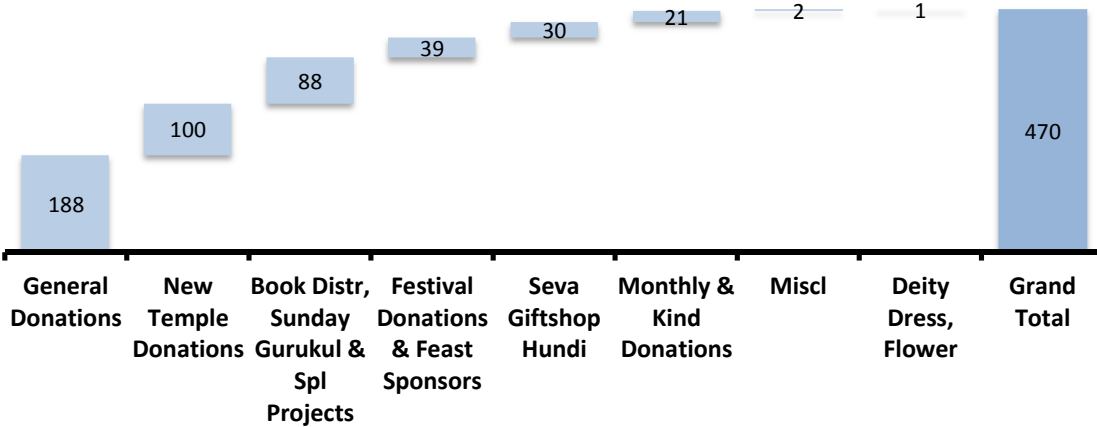

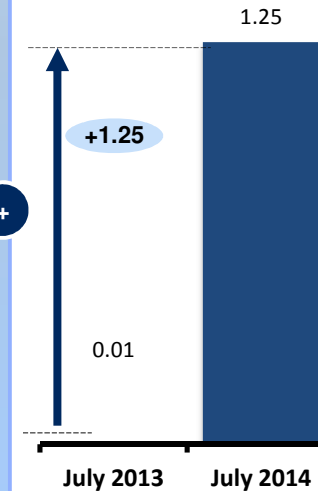
Annual Income (7/2013 to 7/2014)

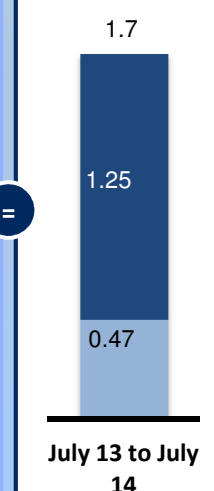
Increase in liabilities
